Meeting called to order. R Swaim went over the meeting procedures.

G Lewis reported on High School Bowling. There were 42 schools last year and the new school year there would 80 all of which will have a Varsity Boy and Varsity Girl team. D Millitello asked if we could not post information on the High School Bowling on our website. R Swaim said she will check on it, but we could post it somewhere.

New Business:

R Swaim brought up the suggested bylaw change to begin with the new season. A copy was in the report folder for everyone to look over.

Bylaw change:

Add a 3rd Vice President to the board of which would be a member of the local Huntsville USBC Youth Program in good standing. The youth would be between the age of 14 and 19 as of August 1. The youth would be the point of contact for youth bowlers. They would get information to the youth programs in the centers about programs and tournaments. They would communicate with the Youth Committee regarding questions or requests from the youth. They will work together with the Association Manager in youth projects.

D Millitello made a motion to accept the new bylaw, motion seconded and passed.

J Mason went over new bylaw from nationals regarding elections. As part of the Nationals Annual Meeting the bylaw covering who votes was changed. The bylaw changed to youth and



adult will vote on all actions with the exception for fees. The youth will vote on youth fees and the adult will vote on adult fees.

Budget: R Swaim presented the new budget for the 2015-2016 season. She stated it was based on 1600 members down some from last year. We were down from last but made the numbers predicted for 2014-2015 in June.

D Millitello made a motion to accept the budget, motion seconded and passed.

On June 29, 2014 at 2:50 the Huntsville USBC held its Annual meeting at Pin Palace. The meeting was scheduled to begin at 2:00 but as we did not have a quorum we had to wait until we got 7 more people present. We had a quorum of 37 at 2:50.

Janice Mason Association President called the meeting to order. First order of business is to change agenda order and go to new bylaw change.

The bylaw is as follows:

Article VII – Meetings - #6 Quorum

It is suggested that the number of Youth Representatives required be moved to 5 and the Adult Representative be moved to 25 for a total of 30.

Prior by law requires 30 Adult Representative and 7 Youth Representative for a total of 37.

The reason for the change is because the decrease in membership and getting enough people to attend the meeting. Martin Smith motioned and was seconded, motion passed going into effect immediately.

The meeting then continued according to the agenda.

Jan Mason gave everyone a few minutes to go over the minutes, financial report, and committee reports. Jill Ferris asked if the unaudited financial report from Quick Books was there and available. She was told it was. It was asked if an outside qualified person would be auditing the books. Janice Mason said yes we were looking for a person to do so. Gloria Jones made a motion to accept reports with the understanding the financial would be audited at close of year in July. Motion was seconded motion passed.

There was no old business from last year's meeting.

New Business:

Bylaw change: We needed to make a bylaw change in association with the Youth Dues as Nationals had changed the fee and break down.

Article IV – Membership and Dues – Youth membership dues

A motion is made from the Youth Committee to have the dues set as follows.

The amount for the local dues will make the program self-supporting for the programs for the youth.



The prior bylaw set by Nationals with a fee of \$17.00 was changed by them for the 2014 - 2015 season. They lowered their fee to \$4.00 and the local could charge what they needed to for their programs. Motion was seconded and passed.

Budget:

A new budget was presented at the meeting. Our count of members has gone down so budget was based on a lower number of 1775. We currently had just over 1800 members; this is 200 less than last year.

We will be planning on going for the entire time to attend workshops that will be available.

Don Millitello made a motion to accept the budget, seconded and motion passed.

We discussed the changes that Nationals has put out in the last few months. One being the bowler not using a thumb in the ball and they cannot have a thumb hole and balance hole. One will have to be filled. We went over the new Basic membership fee for adults and the altering the surface of the bowling ball during play.

Janice Mason discussed that the Alabama Athletic Department is working on the details of the High School Bowling program for this coming fall. Everyone is very excited about it.

Elections:

2nd Vice President

Larry Keel was only candidate for the 2nd Vice President so he was voted in by acclamation.

Directors:

Jill Ferris, Don Millitello, Martin Smith and Keith Hall incumbents and Mary Ann Green from the floor. We had 5 positions open so they were voted in by acclamation.



Rhonda Swaim, Association Manager told everyone the President/Secretary meetings would be held the 1st two weekends in August. One at Plamor, Pin Palace and Madison, they would have to attend in order to receive their league information.

Some had not opened the information sent prior to the meeting so Rhonda Swaim read over the consent agenda. L Keel made motion to accept and A Burnham seconded. Motion passed.

Financial: H Seal Sr made motion to accept the financial report pending proper audit, A Burnham seconded. Motion passed.

Old Business:

Outside Audit: J Mason has given the information to someone and waiting on their reply with signature.

Awards: After much discussion it was decided to use the remaining awards from USBC and a new committee would work to finalize the program with the items to be ordered.

Committee: J Mason, R Swaim, M Webber, Rusty Fowler

Lane Inspection: All lanes have been done and are in the pending status. J Mason said a special thanks to the Fowlers and D Millitello for the extra help they provided in getting this done. They attended most all of the centers. Plamor Lanes was marked as passed by mistake but should be pending.

J Mason has appointed Rusty Fowler at Lane Inspection Chair. He has made an inventory of all of the equipment and has decided that we really could use an extra Gutter Gage and more feeler gages. We are still waiting on payment of 2 houses, Parkway and A& M. With the left over money from last year and this year we should have enough money for this purchase. R Swaim also ordered calibration strips for the lane reader.

On the issue of lack of help with lane inspection R Fowler suggested that a list of the dates be put together and the centers times. He would get in touch with the board and set up a schedule for each person to attend. If a board member does not fulfill his/her commitment it will be counted as part of the attendance policy we currently have in place. For members that are unable to get down on the floor due to health reasons it is asked they do the writing on the reports or get someone who can help in their place. For example get a youth bowler to help out.

Women's State: This tournament will be held at Plamor on Feb 28 – March 1, March 7 – March 8, and March 14 – 15. We will have to set up in the room for most of the paperwork to be done. It is going to require the board to help out with this tournament. This is a minimum number needed is 5 but up to 7 per shift.



We may be responsible to sell shirts at the women's tournament. The Fowlers know of a gentleman that will set up and do shirts at no cost to us. We will actually make 10 - 15% per shirt. It was asked to get a sample of the shirts he has done for the board to consider.

R Swaim showed the board a couple of fans that she and J Mason had found to sell at all of the tournaments. It was decided that we would buy some to start at the Senior Tournament.

150 – Electric fans with lights

300 – Fold up fan.

New Business:

Website: M Webber has had the website set up on his server. Now that it is working we need to move to our server. Based prices and quality of site, he suggested that we use Go-Daddy. The cost per year would be \$70. M Webber made a motion to use Go-Daddy, A Burnham seconded. Motion passed.

It was asked if we could have list of State Tournaments for the web and boards. R Swaim said she would get it.

J Mason talked about the High School Bowling Program and asked if anyone had old equipment to please donate it to the bowlers. M Webber also said McCorvey's Pro shop is offering equipment at a discount to High School Bowlers.

Consent Agenda: L Keel motioned to accept – motion passed

Old Business:

Awards: Rusty Fowler suggested we do a banquet as a way to honor our high score average bowlers. After much more discussion we will need to decide how much the cost would be for such an event. Base it on the amount of money for awards for such awards and decide if it may be something we could do or not. Email cost information to board.

Lane Inspection: Rusty Fowler has not heard anything from the houses on repairs that have been done to re-inspect. Rusty Fowler went after the inspections and did another check on the numbers that was taken. He made the corrections where needed and let the centers know. As of today he has not been contacted about what still remained. R Swaim will send each center a letter regarding these repairs and give them a date they will need to be done by. This will need to be done in order to close out the lane inspection for this season. Redstone and Parkway will have until the end of January and Madison and Pin Palace by the end of February.

Woman's State: Went over the information we will be required to do for the tournament. We will also need to have shirts for it to sell. Rebecca Fowler is going to check on shirts with someone she is familiar with and get back with us. It was suggested to have M Webber get shirts from the company he did for the youth. We took a vote of members as follows.

New Business:

Jill Ferris resigned from the board. J Mason asked J Moore if he would be willing to fill the position to term. He said yes.

Plamor Lanes announced they will be closing their doors at the end of April. R Swaim gave the managers of the other centers the contact information of the leagues. Hopefully they will all find a new place to bowl next season.

R Swaim attended a webinar on the Coaching Clinics we have to have for the association this season. We are required to have 3 hosted by us. Nationals said to set up a committee to head this job up. The committee will consist of R Swaim, L Keel, K Hall, G Lewis, and J Moore. One clinic R Swaim would like to see held is for the High School Officials to spark more interest in High School Bowling.



The Association received our score from Nationals for this session. We got a C; this covered the test the board is supposed to take. 3 people said they had issues with the site. J Mason said we need to get in touch with our regional director. R Swaim said she would.

L Keel reported on the meeting at the State Board recently. They opened the Bid for the Open Tournament back up. Issues unknown regarding the prior choice made.

D Millitello brought up that Bowler of the Year needs to be finished. He and R Swaim would try to get a hold of M Webber on this.

The Association Manager sent out a consent agenda consisting of the following:

Financial Report

Lane inspection report: R Fowler had been in touch with the centers regarding lane repairs. There was a reflection made by the manager of the AMF centers that they may not want to comply. They had not done any repairs in the 7 months that have passed. He said he would be getting back with corporate regarding this. When R Fowler stated we needed it in writing for nationals. Madison has been working on repairs and R Fowler was going to get back with them to see how we stand on major repairs. A&M has had no reply. Redstone has a new manager and he received the information on what needs to be done. R Fowler will be getting back with them.

USBC requires us to have 3 coaching clinics as part of our grade. R Swaim checked with the centers regarding cost of these clinics. AMF centers will charge \$11 per lane per hour. Madison will charge \$15 per lane per hour. Will be discussed in meeting.

We have the Alabama State Woman's Tournament starting in February and 1st two weekends in March. We will need board members to help with this tournament.

Consent Agenda motioned for approval by D Millitello, motion passed.

Old Business:

Awards: Tabled again the committee will be meeting on February 21, 2015 at Madison to finalize this. An email will be sent out for a final vote.

Woman's State Tournament: Held on February 28 - March 1, March 7 - 8 and March 14 - 15 at Plamor Lanes. We will need board to help with this. Shirts will be sold for a cost of \$15 per shirt.

The youth will be helping porter and help the bowlers get items from snack bar. They will also be having a bake sale for their programs.

Shifts will be assigned to other members as needed.

Lane inspection: A report was sent out the board prior to the meeting. Still waiting on report from AMF centers as to what they will be doing. R Fowler talked to the District Manager on the phone also. They asked for a week to finalize their decision.

The manager at Redstone is getting up to speed on the repairs. R Fowler is meeting with Manager of



Madison to see where things stand on their repairs.

The board was reminded that the inspection information is between the center and the board only. It should not be talked about outside the meeting. Each center is given a list of needed items and they will work with the committee on a time line. All centers will be on Pending Status until other wise decided.

Bowler of the Year Adults: This has been finalized and a copy sent to R Swaim to have it put on the web. D Millitello will also post on the boards at the centers. The report includes All City Team, Center High Averages and Bowler of the Year.

Web: M Smith feels the web still needs to be more navigational. He feels some of the items take to many movements to reach. He would like to see hot links to some of the stuff on the front page. M Webber stated that there is still some work being done and he also hopes to have the web email you when a change is made. D Millitello was made a publisher on the web so he can put articles on. This is our first year with this so we are still working on it.

New Business

High School Bowling: It is touched on that High School Bowling is finally under way and we had 6 area schools participate this year. This is very exciting for the area and hope it will increase our membership.

Coaches Clinic: With the cost of the lanes participants will be charged \$5 per person for it. This is to cover the cost of the lanes. It was asked how many certified coaches we have on the board. R Swaim is a Level 2, J Mason is a Level 1, M Parrish is a Level 1. If a person with higher levels does not keep up CE's with USBC they no longer count. The highest level we have is Level 2.

R Fowler stated he has been collecting items to raffle off with the proceeds to go to Education Clinics for youth bowlers. Some will be done at the Woman's State Tournament to be given the last weekend.

The board went over the Nationals Meeting proposals. J Mason and R Swaim will be attending this year in Omaha Nebraska, the last week in April. R Swaim got a room for the week for \$479.00. They will be attending many seminars while out there.

The next meeting will be held at Pin Palace on June 14, 2015 at 2:00 PM. This will be the Annual Meeting. The board was told to watch emails for information that may need to be voted on in the next couple of months.

In April Janice Mason and myself attended the National Convention in Omaha Nebraska. The workshops they had were very interesting. We both attended different ones. At each one we got the opportunity to pick up on somethings that other associations are doing and share some of our own experiences. During lunch and breakfast we had the chance to talk with other associations also and get their take on things.

The here is some take on the information gathered from the ones I participated in.

Regional Round Up – Both of us sat in on this. We had a chance to meet a couple of the board members and get a look at them as real people. This was very laid back

Opening gathering – There was a motivational speaker at this, his name was Joe Malarkey. He was much like a comedian, but he had a true message to relay. One of the biggest things I took from it was this. "Failure is just a way not to do something. Don't give up if you fail at something just try a different way. Thomas Jefferson tried many times with the telephone and failed until one day it worked."

We then got some insight of bowling from USBC. USBC is made up of 1.5 million league bowlers. USBC is marketing bowling as a sport not a game. To do this it will take the hard work of the over 25 thousand volunteers, us. USBC provides a program in which the associations can put the information of each bowler into a central information bank. They have tournaments and guide lines for each association to sponsor local tournaments. They provide education training tools and resources to the associations and to the schools. As said by Steve Jobs, co-founder of Apple, "Let's go invent tomorrow instead of worrying about what happened yesterday."

Association Success – What does it take to be a success? Board information update. Better contact with the association reps. Board training, prompt membership processing. Coaching clinic for those that want to enhance their game. Tournament participation to increase it and have historical data. Some of the associations are setting up bowling carpets in the mall to expose the people to our sport. This is a good way to get the youth excited about it.

Value of membership – What is the value of the USBC membership? Here are a few.

Championship Tournaments

Charitable Contributions - veterans, and cancer research

Recognition of volunteers – Different ones available on bowl.com

Certification of Centers – to be sure they all meet certain standards

Record averages from leagues

App so you can access your information anytime

Planning for Success – This is a pilot program where Nationals Regional Rep works with the association on setting goals for a successful future. There are 8 currently participating in this of which Huntsville is one. There were several other associations that want to become a part of this. Our first goal was to get more youth involved with lane inspection and become more active in the board so they can be trained to one day take over. This was a good process as for our lane inspection we had several youth participate. We also plan on making a bylaw change to help with this further.

IT – This was just what is says. The youth processing program is terrible. They are working on a new program and are going to have different associations do the testing. They are in the process of choosing them now. The program Winlabs used for adult processing was going to be dropped but with further thought they are enhancing it. Currently Winlabs will only work on XP or windows 7. The new program will work on any computer system even Windows 10. They will also be having testers for this and are working on a list of associations to do that.

Changes to bowl.com coming soon is you will only be able to open the site if you are a member. This will mean you the bowler will need to activate your card and sign in. If you have any trouble with that you can contact me and I will get you set up.

League Rules (majority needed)

Amendment No. LR 1 - Rejected (61 accept, 654 reject)

Rule 109a. Legal Lineup

Changes the default legal lineup to one regardless of playing strength.

Amendment No. LR 2 - Rejected (38 accept, 681 reject)

Rule 111e, Procedure

Allows pre-bowls and postponements to be completed on one lane.

Tournament Rules (majority needed)

Amendment No. TR 1 - Rejected (139 accept, 579 reject)

Rule 319e, Average Adjustment for Entry

Separates a bowler's tournament average into standard and sport.

Bylaws (two-third votes needed)

Amendment No. B 1 - Rejected (483 accept, 247 reject)

USBC National Bylaws

Article II, Purpose

Section B, Chartering State and Local Bowling Associations

Requires non-merged local associations to be merged by August 1, 2018.

Note: An amendment was made to original Amendment No. B 1 to change the effective date for associations to be merged from August 1, 2016, to August 1, 2018. The amendment to Amendment No. B 1 was accepted. (464 accept, 254 reject).

Amendment No. B 2 – Rejected (468 accept, 259 reject)

USBC National Bylaws

Article II, Purpose

Section B, Chartering State and Local Bowling Associations

Requires non-merged state associations to be merged by August 1, 2016.

Note: An amendment was made to original Amendment No. B 2 to change the effective date for associations to be merged from August 1, 2016, to August 1, 2018. The amendment to Amendment No. B 2 was accepted. (571 accept, 146 reject).
