## Huntsville USBC Association 2024-2025 Open Tournament Rules

The United States Bowling Congress Rules and Regulations will govern this tournament.

- **All Huntsville USBC men & woman league members of the HUSBC Association are eligible to enter the tournament. USBC members who are eligible for another association championship tournament must bowl 21 games in a league within the HUSBC Association jurisdiction to be eligible to bowl.**
- Entries close at midnight October 20, 2024. Mailed entries postmarked in accordance with USBC Rule 310a (2) shall be accepted.
- Cash Awards. (Handicap Division) - Cash awards will be made on a basis of 1 out of 5 entries in Team, Doubles, Singles and All-Events from 80% of the prize fund. (Scratch Division) - Cash awards will be made on a basis of 1 out of 10 entries in Team, Doubles, Singles, and All-Events from 20% of the prize fund.
- To be eligible for the All-Events Prize Fund (optional), a fee of \$5.00 must accompany entry. To be eligible for Senior Singles (optional) and All-Events Prize Fund (optional), a fee of \$5.00 **per event** must accompany entry and bowler must be 50 years of age as of November 1, 2024. If participating in all three events total cost is \$15.00
- Multiple Participation: No individual shall bowl more than three (3) times in the Team Event: 2 team members must change. Entrants may bowl no more than two (2) times in the Doubles Event; the partner must change. Bowler's first scores in each event shall count towards their All-Events score.
- For the Doubles/Singles event, **Doubles will be bowled first.**
- Handicap shall be 90% of the difference between the entrant's individual average and 230 in each event.
- Averages: Entrants must use their highest USBC Sanctioned Winter League Average based on 21 or more games from the 2023-2024 season. If no average for the 2023-2024 Winter Season, use highest current sanctioned average based on 21 games or more as of November 1, 2024. All other bowlers must bowl scratch. **USBC Rule 319a (10 Pin Rule) APPLIES FOR THIS TOURNAMENT.**
- Tournament management reserves the right to re-rate any entrant prior to bowling. If the entrant refuses the re-rate, entry fees will be refunded. Entrants have the right to appeal any re-rate to the USBC within 15 days of the date of bowling or prior to the payment of prizes, whichever comes first.
- Failure to use the proper average or make a correction prior to the completion of the first game of a series shall disqualify score if submitted average is lower than actual average or prize winnings will be based on submitted average if it is higher.
- Tournament prizes will not be awarded until the Association Manager has certified the winner's average.
- After entries have been received and the dates assigned by tournament management and they are not refused by the team or individual entrant prior to preparations of the schedule, no fees shall be refunded.
- No change in team lineups will be allowed. If a sub is used, they will go in the position of the missing bowler. Sub changes must be made one (1) hour before the scheduled time to bowl.
- Substitutes must present themselves to the tournament management at least one (1) hour before scheduled to bowl and their averages must be verified.
- All-Events if paid in Handicap or Scratch will be paid to the bowler if it is a sub, it will be given to the sub. Unless others wise stated to Tournament Manager in writing.
- **Pacers will not be permitted.**
- Students who have attained the age of eighteen (18) must have written consent of their parents or guardians to enter. **Students bowling on High School Teams are not eligible to bowl. All Prize Money for Students will be sent to SMART Account.**
- Entry Fees: All entry fees must accompany a completed entry form. No forms will be accepted without entry fee.
